REPORT OF THE LOCAL INQUIRY COMMITTEE

Pursuant to your letter No. Aff/Recog./1492/95, dated 16th February, 1981, we formed ourselves into a committee to make a local inquiry and report on the application, dated 25th August, 1980, from the Principal, Maharashtra College of Arts, Science and Commerce, Byculla, Bombay, for the continuation and extension of affiliation of the college for the teaching of the courses of study mentioned below:—

Continuation of affiliation

F.Y.B.Com. Examination in the subjects of—

- (i) Foundation Course Paper I;
- (ii) Business Communication including Report Writing etc.;
- (iii) Business Economics including Economic Development Paper I;
- (iv) Commercial Geography;
- (v) Mathematical and Statistical Techniques;
- (vi) Accounting and Financial Management Paper I;

Extension of affiliation

(I) S.Y.B.Com. Examination in the subjects of—

- (i) Applied Component Paper I—Panchayati Raj or Community Development or Export Management or Marketing Research or Regulation of Trade Practices or Farm Management including Financing or Advertising or Journalism or Tourism and Hotels or Cooperative Management or Labour Welfare and Industrial Relations including Trade Unionism or Mass Communication;
- (ii) Business Economics including Economic Development paper II;
- (iii) Commerce and Marketing (Business Planning) Paper I;
- (iv) Business Law;
- (v) Foundation Course Paper II;
- (vi) Accounting and Financial Management Paper II;

(II) Hindi (3 or 6 Units) Major for B.A.;

Zoology (3 or 6 Units) Major for B.Sc.

We visited the college on 16th June, 1981. We were received by the Principal of the college and the concerned teachers. We were furnished with the necessary information and shown round the library and laboratories. We have to report as under.

FULFILMENT OF CONDITIONS

The college was permitted to teach F.Y. B.Com. course from June, 1980 for one year and the conditions laid down were as follows:—

Condition No. 1:—That the college authorities will appoint the following teaching staff by the appointment of persons with qualifications and experience approved by the Executive Council:—

- One part-time Lecturer in Accounting and Financial Management;
- One part-time Lecturer in Commercial Geography.

Report:—The condition has been fulfilled.

Condition No. 2:—That the college authorities will spend an amount of Rs. 6,000/- on the purchase of books, reference books and journals during the year 1980-81.

Report:—The condition is substantially fulfilled. The college had spent an amount of Rs. 5,000/- on the purchase of books and journals.

Affiliation:—The college was established in June 1968. From the academic year June 1979 the college has been granted permanent affiliation for teaching the following courses of studies:—

- (a) English, Urdu, Persian, Arabic, Marathi, Philosophy, Economics, History, Political Science, Islamic Culture and Sociology—Ancillary and Major;
- (b) Sanskrit, Hindi, Gujarati, Psychology and Commerce—Ancillary;
- (c) Labour Welfare Industrial Relations including trade unionism, Co-operative Management, Nutrition, Book-keeping and Accountancy, Business Communication, Home Management, Child Psychology and Child Guidance, Computer Programming, Financial Management and Cost Analysis, Planning and Developmental Strategies, Secretarial Practice, Catering-under the Applied Component;

B.Sc.

- (a) Physics and Botany—Ancillary and Major;
- (b) Chemistry and Mathematics—Major;
- (c) Zoology and Economics—Ancillary;
- (d) Bio-Physics, Bio-Chemistry and Geo-Physics—Inter-disciplinary;
- (e) Elements of Social and Economic Life in India and History of Civilization, History, Methodology and Philosophy of Science—Foundation Course;
- (f) Electronic Instrumentation, Drugs/Dyes, Analytical Instruments, Science Communication, Journalism, Radio and T.V. Polymers, Fishery Biology, Food Production, Marine Science and Computer Science—Applied Component, Group.

PRESENT APPLICATION

The subjects of Hindi and Zoology are to be raised to Major level as a natural growth subjects. The number of students at F.Y. B.A. for Hindi is 130 and at S.Y. B.A. is 50. This indicates the enthusiasm of students for the subject and the need to start it at the T.Y. level. Incidentally the college has two teachers (both in P-I category) who are Ph.D.s and are fully qualified to teach honours classes. One of them is a recognised post-graduate teacher of the University. Total number of lecturers will be 24 if only 3 units are permitted

and 36 if 6 units are allowed to be offered at the T.Y. level. Hence there is no need to appoint additional staff. The library needs to be strengthened. The college will have to spend an amount of Rs. 3,000/- per year for the next three years, beginning from 1981-82, on the purchase of books in Hindi and library magazines, in addition to its normal expenditure on library books.

As regards Zoology we have to state as follows. The number of students for 1981-82 is expected to be F.Y. B.Sc. 63; S.Y. B.Sc. 42 and T.Y. B.Sc. 20. The total number of periods of lectures (39) and practicals (63) per week will be 102. The number of existing lecturers in the department is 3. The number of periods of lectures/practicals that remain to be assigned and for which additional staff will be required is 42. The college will thus have to appoint two full-time lecturers in Zoology. The appointments of two full-time lecturers in Zoology is accordingly recommended. As regards laboratories facilities, we have suggested to the Principal for making available one more room for Botany and Zoology. This is essential. The college should spend an amount of Rs. 15,000/- on the purchase of equipment for the Zoology laboratory during the year 1981-82. The library will also have to be strengthened and purchases of books, reference books and journals worth Rs. 5,000/- during 1981-82 is recommended.

As regards S.Y. B.Com. examination the college will have one division in 1981-82. The staff requirement will be one part-time Lecturer in Business Law, one full-time Lecturer in Commerce and one part-time Lecturer in Accountancy. The Commerce man can take Applied Component subjects. The above mentioned appointments are recommended to be made for 1981-82. An expenditure of Rs. 12,000/- is recommended on the purchases of books, reference books and journals for the Commerce Section of the library during 1981-82. The staff appointed for F.Y. B.Com. will have to be continued.

We recommend that the college be permitted to have two divisions each of 100 students, of F.Y. and S.Y. B.Com. class and that any additional division, if found necessary in future, be opened with the prior approval of the University.


